**Race Day Registration:** September 13, 2026, 6 a.m. – 6:45 a.m. Any available shirts will be on a first-come, first-served basis.

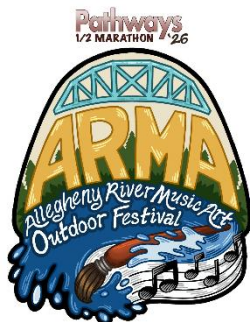

I am signing this Agreement freely, voluntarily, and competently, and am at least eighteen (18) years of age.

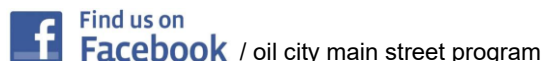
